The Griff is an award-winning 18-hole Robert Trent Jones designed course built in 1964. The Griff is recognized as one of the premier golf courses in the area. We are honored to announce that we've hosted the 2018 Metropolitan Golf Association Public Links Championship. The Griff has also previously hosted an official PGA professional event. In an article written about the course, Greenwich Magazine referred to the Griff as Greenwich's "hidden gem".

While the course is of championship caliber, each hole has four sets of tees to accommodate golfers of all abilities. Practice areas include; a driving range, putting green and chipping area with a sand trap. Also on premise is a full-service restaurant and a Pro Shop with a resident Pro and assistants that are available for lessons along with a full range of golfing supplies and clothing. Further, there are four very active men's and women's golf clubs that play every week during the season. The clubs always welcome new members.
